3. Ordnance Pty Ltd accepts no responsibility or liability in any form what so ever for any personal injury, disablement, death, personal property lost or damaged whilst The Player is on the property and that customer's vehicles are parked entirely at their owner's risk.
4. Any personal injury, disablement or death arising from or associated with the participation of The Game or any activity on the premises is voluntarily assumed by The Player and if not of legal age The Guardian knowing The Player has voluntarily assumed any and all risks.
5. Any breakage or loss of equipment loaned to The Player during the day will be charged to The Player and The Guardian at cost price and the balance of any monies owed to Ordnance Pty Ltd must be settled before leaving the site. No credit can or will be given.
