The Player confirms that they are physically fit and mentally able to take the strain and exertion involved in participating in the game, further the Player and the Guardian confirm that the Player has no medical, mental or physical condition or ailment that prevents the Player from participating in the game, and if the Player does participate in the Game, it is at the Player's own risk and is voluntarily undertaken. Further, the Player and the Guardian understand the property is natural bushland with natural dangers like, but not limited to, potholes, fallen branches, poisonous animals, insects and other hidden and obvious dangers. Ordnance Pty Ltd and the property owner are not responsible and accept no liability for any injury, disablement, ailment or death suffered by the Player whilst on the property, in any way whatsoever.
3. Ordnance Pty Ltd accepts no responsibility or liability in any form whatsoever for any personal injury, disablement, death, personal property lost or damaged whilst the Player is on the property and that customer's vehicles are parked entirely at their owner's risk.
4. Any personal injury, disablement or death arising from or associated with the participation of the Game or any activity on the premises is voluntarily assumed by the Player and if not of legal age, the Guardian, knowing the Player has voluntarily assumed any and all risks.
5. Any breakage or loss of equipment loaned to The Player during the day will be charged to the Player and the Guardian at cost price. This and the balance of any monies owed to Ordnance Pty Ltd must be settled before leaving the site. No credit can or will be given.
